2. Restrictions. Licensee acknowledges that El Fresko Technologies LTD owns all rights, titles, and interest, including copyright and trademark rights to the Software. Licensee may copy the Software only for backup or archival purposes. Licensee may not modify, adapt, translate, create derivative works, disassemble, decompile or otherwise reverse engineer the Software, and you may not sell, lease, assign, sublicense or otherwise transfer the Software, in whole or in part.

3. Limited Warranty.
